**TERMS AND CONDITIONS :**

1. Month Membership: member has applied for a monthly membership. In consideration thereof and notwithstanding any of the other terms and conditions of this Agreement, the Member's Parents shall be liable for fees and services for the full month term of this agreement in the amount as stated herein regardless of usage. After the initial month terms membership has expired, this Agreement shall automatically continue from month to month at the prevailing rate which is subject to change until 30 days written notice is provided to Center Stage. Notice is not accepted in the months of October & November.
2. Cancellation & Refund Policy: All members are entitled to terminate this Agreement via a written notice to Center Stage within three (3) days of making this agreement. After the initial 3 day trial period 30 days written notice is required to terminate all memberships. 1 Months' notice with 1 full months payment to be given in when resigning. 1 Months' notice with 1 full months payment to be given in when resigning. 1 months' notice is as of the 1st day of the following month.
3. Returned payments & published fees. Any payment made that is returned or is uncollectible will be assessed a returned item. All member fees are subject to change at Center Stage discretion except that prepaid membership fees are not subject to increase until the expiration of the current term.
4. Collection of fees: Members Parents will be liable for any collection fees, reasonable attorneys fees and all other expenses incurred by Center Stage in collecting an overdue account. If you account is in arrears, you will be handed over. Any member whose account remains unpaid thirty (30) days after the date charged may at the discretion of Center Stage have their membership privileges terminated.
5. Fees are to be pre-paid by the 1<sup>st</sup> day of the 1<sup>st</sup> month of each term. All school holidays, personal holidays are included and are to be paid for. Fees are due for 11 or 12 months of the year, depending on when the lessons commence.
6. The person responsible for the account also undertake to notify the trainer, in writing should there be any change of personal information. The parties further agree that the liability in terms of this agreement will not be ceded to any party and that all the parties consent to the jurisdiction of the Magistrate's Court should any disputes arise from this agreement.
7. Liability Waiver: All exercise and participation is done at the risk of the Member and their Parents and Center Stage is not liable for theft, loss of personal property or injury including bodily injury or death. Member acknowledges that Center Stage will not accept responsibility for theft or damage to any personal property. In consideration of this Membership Agreement, Members Parents hereby assumes all risks associated with the use of Center Stage facilities and waives all right, and rights of Member's guests, heirs, administrators, executors, successors and assigns and hereby agrees to release the operator, building owner, building manager, any of their affiliates and Center Stage from and indemnify such parties against any and all claims, including but not limited to personal injury including bodily injury or death. As used herein, the word "Center Stage" means Center Stage and their direct or indirect owners, operators, successors, assigns, employees, officers, directors, shareholders, agents and all persons, corporations, partnerships and other entities with which they are or may in the future become affiliated. Any party benefited by the terms of this liability waiver shall be entitled to rely on and enforce such terms. The terms and conditions contained herein constitute the full Agreement between Center Stage and the Members Parent, and no oral promises made are a part of it.  
The Member Parents hereby confirms that he / her child to be enrolled for a programme of exercise offer by Center Stage and that he / she are aware that:
  - The programme is one of strenuous physical activity.

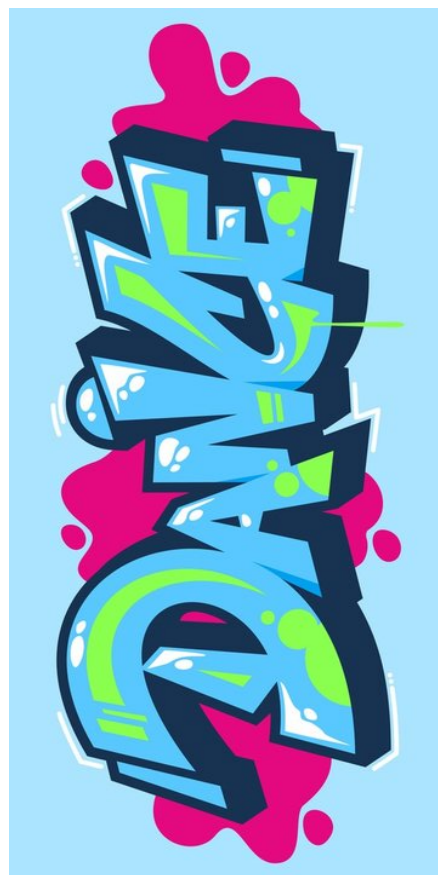
